What you need to know:

Please note: The minimum loan amount is **£50,000**, unless otherwise stated.

- 1 Early Repayment Charges apply during the product term. Up to 10% of the original mortgage amount can be overpaid each year without charge, however, if the mortgage is redeemed or switched to another product during the product term then the Early Repayment Charge will apply.
